- . obtained an English-language diploma in secondary or higher education from an institution in one of the following countries: United Kingdom, United States of America, New Zealand, Australia, Canada (except Quebec), Ireland, Caribbean islands & South Africa. This implies that applicants who did not obtain their GCE A Level certificates in one of the countries above have to submit language test (cf. above) results.

**Scholarships\*** If you pass at least 60% of your registered credits in the first exam period, you will get a reduction on the tuition fee in the following semester.

Thomas More requires a **blocked account procedure** to prove your financial solvency when applying for student visa .You make an advance payment of your monthly living expenses (13 months for FALL semester, 8 months for SPRING semester)

- . Blocked account Fall 24/25:  $\in$ 850,00 x 13 months +  $\notin$ 250,00 administrative fee =  $\notin$ 11300,00
- Blocked account Spring 23/24: €850,00 x 8 months + €250,00 administrative fee = €7050,00

### **BACHELOR PROGRAMMES ADMISSION REQUIREMENTS-**

- . A secondary school/high school diploma with evidence of a background in Mathematics for Bachelor
- Proof of command of the English language, usually IELTS 6.0 /TOEFL 72

### MASTER'S PROGRAMMES ADMISSION REQUIREMENTS-

. Undergraduate degree.

- Proof of command of the English language, usually IELTS or TOEFL IBT results (minimum 6.0 and 72 respectively).
- For MBA only-Undergraduate degree with atleast 3 years of professional experience

#### Scholarship:

. 50% Scholarship could be offered in terms of potential MBA students.

#### **Required Docs:**

- . Secondary school/high school diploma and breakdown of individual subjects and grades (in English or French)
- . Scan of their passport
- . Portrait photo
- . Proof of command of the English language
- . Personal statement: a 300-word critical analysis on the programme's potential contribution to the applicant's personal and professional development.
- . CV ( for masters program)
- . Two reference letters. These letters are expected to make explicit reference to the applicant's potential to develop a professional career in business and to pursue Master's level studies.
- . 500-word personal statement: a critical analysis of the program's potential contribution to the applicant's personal and professional development. ( for master's program)

#### Interview

Candidates recommended by the Admissions Board are invited for a 30-minute interview with the Programme Director. Interviews for international candidates are usually conducted on Zoom.

#### Scholarships

UBI Business School offers various entry scholarships and tuition support programmes for prospective and currently enrolled students.

Visa students are required to provide proof of means of subsistence as part of the visa application process. These funds are aimed at proving that students have the minimum amount required to cover living costs, studies, and repatriation costs.

# For the 2023-2024 academic year in Belgium, the minimum required fund is 789 X 12 months = EUR 9,468.

i.e. International applicants need to secure around EUR 15,000 (means of subsistence + tuition fee + administration fee) prior to applying for a visa.

Important note: it is highly recommended that this fund be safely secured in a blocked account, which UBI can help applicants setup.

Applications for the autumn semester begin on 1 January of the same year.

### Application deadlines for the academic year 2024-2025:

1 June, 2024 for non-EEA students who will need to apply for a visa in order to study in Belgium

15 June, 2024 - final deadline for payment of the blocked account money, the non-refundable deposit and providing legalized documents. Any incomplete application will be rejected.

For our postgraduate Certificate Programmes the deadline is 1 May, 2024 for non-EEA students

The application processing fee is 50 EUR and is non-refundable

. as a non-EEA citizen, you will need to have an additional **11.000 EUR/year** for your visa application and to cover your cost of living in Belgium. This amount will have to be provided annually during your stay in Belgium.

### Language Requirements:

- . Ielts minimum 6.5/Duolingo minimum 110
- . TOEFL: minimum score: 550 points (paper-based), 213 points (computer-based) or 79 points (internet-based);

. proof that you have successfully completed at least one year of a full-time English-taught study programme in secondary education or at least 30 credits of an English-taught study programme in higher education have been successfully completed;

#### **Required docs**

- . a copy of your passport/ID;
- . atranslated and<u>legalized copy of your diploma</u> with transcript of records, or transcript of records and expected graduation document from your school;
- . an official English language certificate certifying B2 level;
- . amotivation letter;
- . If asked: a math test or a portfolio.
