

Why Netherland?

The Netherlands is a small country in Western Europe, with a rich cultural tradition, high quality education and a great work-life balance. Its relatively small area of just over 41,000 square kilometers is home to more than 17 million people.

- ⌚ Wide range of English-taught programs

- ⌚ Non-EU students can either work **16 hours a week** during the academic year or choose to work full-time during summer (June, July and August).
- ⌚ Candidates applying for most part time work do not need to speak Dutch
- ⌚ Only the employer can apply for the work permit from the Employee Insurance Agency (UWV Werkbedrijf) and the process usually takes around five weeks
- ⌚ Average **wage for students is 20 euro per hour**
- ⌚ **Please note students working part-time students will need to obtain Dutch Health insurance at a cost of about 35-40 EUR per month or €420 -480 p/y)**
- ⌚ five years of consecutive legal stay in the Netherlands a valid resident permit or temporary stay permit on the time of applying for permanent residency knowledge about Dutch society
- ⌚ International graduates can therefore apply for an orientation year. This is a residence permit of one year to find a job, or start a business within three years of graduation. This residence permit gives you free access to the Dutch labor market.

1. If the tuition fee is paid at once, a **€ 350** discount applies. If the tuition fee is paid in 12 instalments, the total tuition fee is € 22,250. For students from outside the EU/EEA who choose to pay in 12 monthly instalments, the first two instalments will be invoiced before the start of the academic year - on 1 July and 1 August for the September intake or on 1 November and 1 December for the January intake.
2. The Dutch immigration authority requires you to prove that you are able to meet the financial requirements of living and studying in the Netherlands. In order to show that you are able to meet the financial requirements towards Tio, we offer several options. Tio will inform you accordingly and assist you.

- ☹ A copy of your birth certificate, with an apostil or double legalization.
- ☹ A copy of the original documentation of your Higher Education qualifications.
- ☹ A legalized copy of all previous educational qualifications translated into English.
- ☹ A legalized copy of recent mark/grade lists translated into English.
- ☹ A color passport photograph - digitally (according to Dutch rules, taken from the front side of the face).
- ☹ Proof of English language proficiency: TOEFL: iBT \geq 75-80 points (Institutional TOEFL code Tio: 4764). IELTS academic: \geq 6.0. (Bachelor)
- ☹ TOEFL: iBT \geq 90 points, IELTS academic: \geq 6.5 overall (Masters)

- . **International Students:** The high school diploma must be equivalent to the Dutch qualifications. Our admissions team will carryout the Diploma Verification for you.

Pre-Master's:

- . For students with a Bachelor's in non-business domain (Finance, Trade...)
- . Required for Master of Business Management
- . Always in combination WUAS Master's programs.
- . For students who have not studied a bachelor's in the domain of economics management or hospitality and tourism, or have followed the bachelor's programme that does not conclude with a research paper or a dissertation.

Here is an overview of the Application Process:

1. Submit application Package
 - . Completed Wittenborg application form
 - . Letter of Motivation
 - . Curriculum Vitae
 - . A passport-type photo
 - . Copy of academic transcript(s) and diploma(s) (All levels)
 - . Copy of your passport
 - . Copy of IELTS/TOEFL
 - . Only for MSc and MBA: Two recommendation letters (MSc at least 1 academic letter / MBA at least 1 from work)

2. Interview

- . Once we have received all application documents, the Admissions Board will evaluate the eligibility of the student into the programme. This process may take up to 1 week. Hereafter, we will schedule a short Skype/telephone interview with the student.

3. Admission Decision

- . If the Admissions Board finds the student eligible and the interview has been conducted satisfactory, the student will be granted Admission. Within 1 week our Student Registrar will then send an Acceptance Letter, Study Agreement and Invoice.

4. Student Visa Application (if applicable)

- . Once the student has accepted the offer and the invoice has been paid, we can proceed to applying for the student visa. In order to do so, the student will need to sign certain documents as well as provide us with an original bank statement (posted to the university and dated after the tuition fees have been paid) showing that they have at least €11,500 on their bank account. As soon as we have received the approval notification, we will inform you and then the applicant can go to the nearest Dutch embassy to pickup their visa.

The application deadline for the September intake will be:

- . June 30th, for Non-EU/EAA citizens and

Non-EU diplomas:

- . accept most non-EU qualifications which give access to higher education in your country. Our team will assess your high school diploma. You will also need to provide an English Language proficiency certificate. exceptions are made for English-speaking nations.
- . this entrance examination is intended for prospective national or international students 21 years or older on our program's start date. By doing the 21+ Admission Test, you will take an entrance examination and receive advice on your abilities to follow your chosen study program.

If you do not meet the above requirements, we maybe able to offer you an entrance test. Passing this test would allow you to join our Bachelor of Science if you are 21 years old or older.
